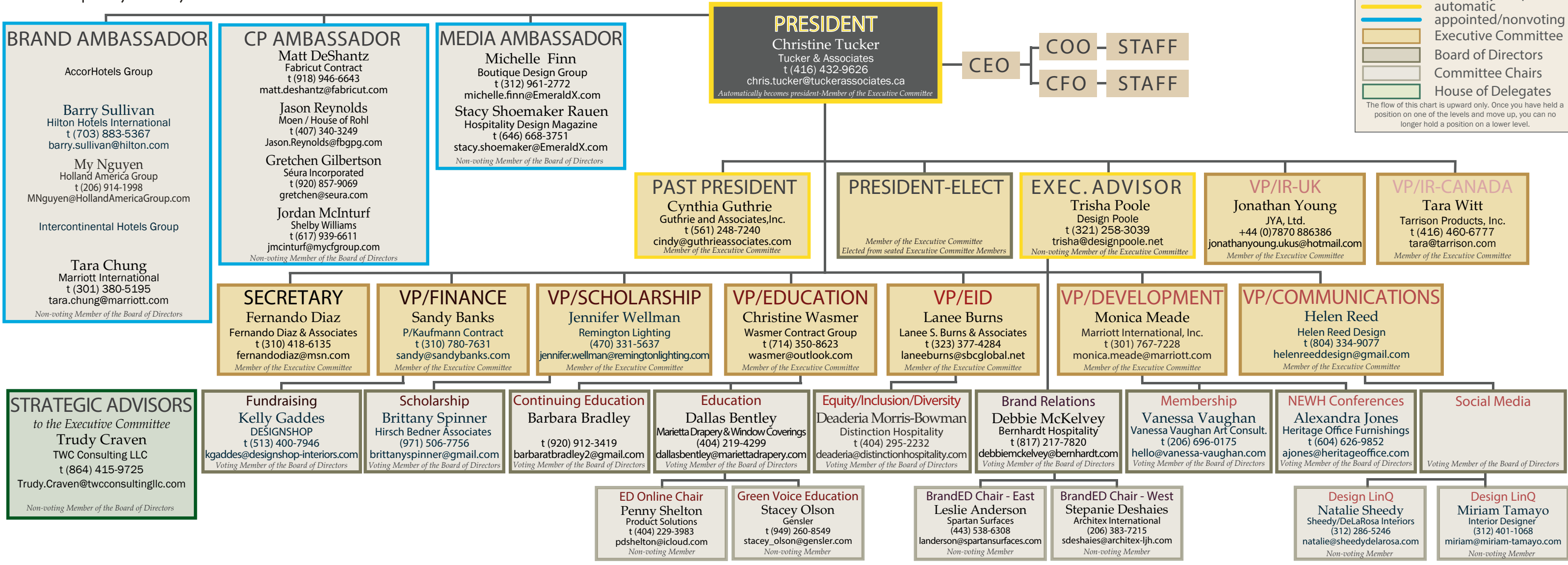


2021 Board of Directors Organizational Chart
